LOCATION: Kroger's parking lot, 1237 Coolidge Hwy, Troy.

INCIDENT DESCRIPTION: At 1348 hrs on Saturday, June 2, 2012, a 78 yr old female from Franklin, MI, driving a 2011 Cadillac, pulled into a parking space on the east side of Kroger's, 1237 Coolidge Hwy, and struck a pedestrian, a 69 yr old man from Berkey, MI. The pedestrian sustained serious injuries. The vehicle was lifted off of the man by the Troy Fire Department. The victim was transported to Royal Oak Beaumont Hospital by Alliance Mobile Health where he remains in critical condition. Members of the South Oakland County Crash Investigation Team (SOCCIT) were called to the scene. Alcohol and/or drugs do not appear to be a factor in this incident.
